1. CALL TO ORDER

Dustin Lent called the meeting to order at 2 p.m.

2. CASES TO BE HEARD

Case #03-2023 23417 Glenbrook – Lauren Sayig

Request to install 6-ft wooden privacy fence around perimeter of rear yard. Removal of chain link fence on the rear and left side property lines, so the good side of new fence will face out. The right-side chain-link fence is staying, so the posts are on the outside and the good side of the new fence has to face in.

Petitioner said on that side that faces Greater Mack, those neighbors didn't want the chain link removed. I submitted a picture, from the start of the driveway to the garage, there's only enough room for a post. Then the flat side wouldn't have fit between the chain link and the post. So that's why on that side it would be opposite. Lent reiterated that the neighbor requested the chain link to stay, so in order to let it stay, you're forced to put the good side in. Petitioner said yes.

Tony Monday said I'm on the opposite side, we're all for the privacy fence. But she has trees down that side, so I understand why they want to remove the fence on my side. Monday went into detail about other trees on the property, how it's affecting his basement wall, driveway, etc. I want the trees to be removed, then I'd have no problem taking the chain link fence down. After Monday gave a lengthy explanation of his issues, Lent explained to Monday that his issues aren't relative to this case. Trees and property line issues aren't heard at this board. He told him could trim the trees if they grow on his property. He explained to Monday that the portion of fence on his side is allowed, without this board. It's the opposite side that needs a variance from this board.

Motion by Lent, seconded by Accica, to approve the request.
